4. FIRST AID MEASURES

4.1 Description of first aid measures

Еуе	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

5. FIRE FIGHTING MEASURES

7.1 Precautions for safe handling

16. OTHER INFORMATION

Additional information WORKPLACE CONTROLS AND PRACTICES: Unless a less toxic chemical can be substituted for a hazardous substance, ENGINEERING CONTROLS are the most effective way of reducing exposure.
